**POLICE** – **Biscontini** thanked Jeff Gustinucci and DPW going forward they will be assisting the police department with the evacuation drills at the schools. Chief Binker made arrangements for a speaker to talk to the senior citizens about scams on Monday.

**FIRE** – **Sax** reported the department had 124 fire calls, 68 captains calls for a total of 192 calls for the month of September. October is fire prevention month. Reminder to check your batteries in your smoke detectors and carbon monoxide detectors. Practice your family evacuation plans if possible. To date the firemen have installed smoke alarms in 136 households.

**DPW** – Shubilla reported that for the month of September: 205 tons of garbage and 37 tons of Co-Mingled Recycling. Note that West Saylor Avenue has been closed since 9/30/2022 and will be closed for one month. Reminder that Saturday, November 5<sup>th</sup> from 9:00 A.M. to 11:00 A.M. there will be electronics recycling at the municipal park. Most small items there will be no charge. Larger items have a small charge. Also from 9 A.M. to 12 Noon the same day there will be a paper recycling event. Confidential papers can be shredded free of charge.

**RECREATION** – **Cinti** reported that mini football, cheerleading and soccer are done at the park. Trunk or Treat will be Sunday, October 30<sup>th</sup>. The bathrooms at the park are being updated, so they will be temporarily closed. In January we will start accepting requests for the pavilion rental. I'll know next month if the rates are going to stay the same.

#### TAXPAYERS:

Mark Saksa – 59 Maple Street in the Fox Hill Section of Plains. Commenting on the last concert that was held on September 30<sup>th</sup> at Mohegan Sun that the Board gave permission to hold. The noise was so devastating that the bass was vibrating the walls in his home. It was going on from 7:30 to 1:45 in the morning. Asked what the criteria is used to approved these permits. Called the police department twice that night. Questioned the noise ordinance. Board said it was the Brett Michaels concert. Karen Rubasky explained the process of the special use permit. Chief Binker also explained the noise ordinance and how the department charges under the disorderly conduct state law. The Board was not aware of the concert or noise complaints, but will look into the situation. Also Saksa, complained about the noise barriers being taken down by developers of the Dolphin Plaza and the Casino. The noise is unbearable enough where he can't keep his windows opened at night or during the day. Asked if anything could be done about the Jake Brake noises from the Microtel to the Casino entrance and E. Main Street to Route 315. Board we would have to request a study from Penn Dot. Saksa is requesting Jake Brake signs to help alleviate the noise that has gotten worse. Yozwiak we will request a study from Penn Dot.

Kathie De Vincenzo – 5 Skyview Drive their street is constantly deluged with water after a storm. Thanked the Board for approving the Hilldale Project. Something happened in the last 10 days that she is getting water gushing into her sump pump. Waiting for pump to kick and basement be destroyed. Yozwiak asked if she called the water company that she may have something leaking in the neighborhood. De Vincenzo did call the water company and they tested it and said it is ground water because there is no chlorine in the water. Yozwiak and Brian Palmiter explained the Hilldale project. Project has to be done by May. De Vincenzo asked if the catch basins could come in the mean time to unblock. She thinks someone altered the water table. Cinti said he would call WVSA to unblock. Brian Palmiter is also going to meet with them to discuss further and look where they could put catch basins. Yozwiak told them you could connect to our catch basins but we cannot go on your property.

Steve Grzezdzinski – 28 Martin Street and is looking for an update on the landscaping business that is in his neighborhood because it is business as usual. Nothing has changed. Asking if they were cited and relocated. Karen Rubasky, Zoning Officer explained the status and what has happened since the zoning hearing. Received notice in July to cease operations. Has issued citations and is awaiting a court date. Filing citations weekly. We went through the steps. Biscontini and Sax asked when did she start citing him. Rubasky said she just started citing him this month. He said he was looking for another property to re-locate to. Yozwiak that is the status. We gave him notice and we are citing him and just waiting for a court date. Grzezdzinski and Board wants to know when the hearing is scheduled for. Shubilla asked if he can be cited every day. Menn said that's not going to make a difference.
