TAXPAYERS

Judy Rome - Lives at 47 South Beech Road. Recently became aware that the property at 7 North Beech Road has been acquired by Keystone Services and is running a business out of that home. Asked the Board how and why that is allowed. Menn offered to sit down with the residents to explain the situation after the meeting. Federal Law, the Fair Housing Act has defined use as family. So if your in a R-1, the definition of a family includes unrelated individuals. People who are suffering from mental handicaps as a group that would live together as a family under the Act. They become a family so they do not violate the ordinance. This is expanding more and more. Facilities are closing and now they are trying to put these patients in a residential-settings. From a zoning perspective, they are operating as a family that meet these categories. Rome this is a business that is employing people. Asked if she could rent an Air BB out of my residence. **Menn** that is not the same thing. The question is how they are operating. Rome the other day there were 7 cars parked there. We have traffic concerns. Menn asked if they were illegally parked. Biscontini responded that we did have a traffic study done by the police and they found no issues. Chief Binker explained that the study was done by Officer Mahmoud and we found no traffic accidents there and no parking issues at that intersection. Has no problem with another stop sign. None of the other departments have a problem with that intersection. There are zero parking citations or complaints since 2018. Mark Pawlowski spoke from the audience asking that don't they have to provide parking for a business. Zoning Officer Karen Rubasky explains the zoning and parking regulations as it pertains to this property. Menn ownership of the property does not define use. Biscontini asked if someone disagrees with you, what option do they have? If they feel their covenants of Birchwood Hills have been preached, what are their options? Menn covenants are private actions that can be taken among residents. You wouldn't come to the Township if someone is in violation of your covenants. You need to talk to a lawyer about that understands the housing act and the zoning ordinance. Once the streets are turned over to the Township, they become public roads. Biscontini lives in Birchwood Hills and could probably find a real estate attorney to help. He can't because it would be a conflict. It's a private cause of action. Menn this is not the only group home in Plains Township and as these started appearing, this use was reviewed by the Zoning Board solicitor and myself with Karen. Rome feels that this use is devaluing our properties. What's stopping more to be bought and set up next to this home because they are also ranch homes? Shubilla intervened that we should cut this and move on.

Jim Waz - Lives at 24 South Beech Road. Has two questions. Is Keystone Services a non-profit and are they paying taxes? Could you find out for us? **Barbara Bruno** spoke from the audience. Doesn't understand how this is allowed. It's a business, not a family. **Yozwiak** we can find out if they pay taxes. They purchased the property in May of 2021.

Paul Menendez – Lives at 21 Mill Creek Road in Mill Creek Acres. Came here to address a drainage problem and has safety concerns. There is a condition that happens late winter and early spring between the curb line, condition on the street sub-surface water comes up about a half block up from his property. Did call DPW and left a message for Mr. Gustinucci. When someone did show up, the water subsided. The water got in between the binder and the wearing course and pulled the wearing course up.

Has an outlet by his driveway but during a rain event of when this water is coming up to the surface, it goes around the inlet instead of in it. Yozwiak they are putting a new water line in Hilldale and Jeff did mention there was a problem in your development just like they have. It's on our list. I'll talk to the engineer. Menandez showed pictures to the Board of what the problem looks like. Pictures given to Nick Argot.

Judy Rome - Also has a water problem in front of her home at 47 S. Beech Road and it is also in front of Kevin O'Connor's home at 45 S. Beech Road. It's not graded properly and in the winter it freezes up and people have a had time walking. Waited for the trash pick up because I didn't want the guys falling so I handed my garbage to them and told the two young men on the back to ask road department take care of this area. They said no problem, but the driver however was disrespectful. Driver said it is like this all over Birchwood Hills. Called to DPW and told them about incident and they said they would put reprimand in his file. Shubilla will take that under advisement. Yozwiak added that there are two problems up there. The surface water and your rain gutters come out to the road. Sax said the Water company just did work there and were going to repave. Engineer will monitor the situation.
