Joe Granteed – I first want to say that the new officers and their families seem very nice, but when I came here last month I had a lot of questions about their hiring and I feel that none of them were answered correctly. I am here to object to their hiring on the basis that I don't believe they are United States Citizens, the Civil Service Commission is not following regulation and these people are not citizens of the United States. None of the questions have been answered. Commissioner Sax- We have a civil service commission that vets these applications and sets rules.

Granteed – I believe the Civil Service does not require them to be US Citizens I will be filing a FOIA (freedom of information act) to get the answers. I have a bunch of people and we are going to get together and draft a FOIA with all of the questions that need to be answered, because just like in California and Indiana you are hiring Illegal Aliens. These can't be the only two people that were qualified to be officers.

Commissioner Biscontini – There were 3 applicants that applied and passed the test and were offered the job, one took a job in a different town, or we would have hired 3.

Granteed – They are wonderful people but they are out in the parking lot speaking Spanish so I have questions and doubts, I should get to know who is going to be pulling me over especially if they aren't from here. Do they live in Plains Twp.

Commissioner Yozwiak – There is a contract they must follow all conditions of the union contract, they have so long to find a place in Plains Twp.

Chief Binker- In order to get into the Police Academy, you must be a US Citizen so all of their paperwork was checked before they were even sent to us to apply for our test.

Granteed - I'm filing a FOIA because I don't believe they are citizens

Civil Service Secretary – They are US Citizens I verify their paperwork myself. The Chief does their background checks, this is a requirement.

Nancy Stout -

Takes Home School Families to the Park on Fridays from 12-2:30 and would like the restrooms opened up for them because the porta johns are just not a viable option for some of the younger children.

Commissioner Cinti – will get in touch with her and the Recreation department and get that taken care of.

Bill DeAlba -

He is from Clarks Street and there are water problems on the Street. He says after it rains the water runs down the street for days., and in the winter it turns to ice. Can we make sure that there is nothing blocking the drainage trench like last time.

Commissioner Yozwiak – We did the drains and the water project on Skyview We are paving it next year so we will be sending the engineer down to see if we need to put in a bigger pipe.

Audrey Serniak – I would like to congratulate you all for the new hires they are a welcome addition to the township, they were properly vetted and ready to follow the rules. I would also like to say it was no secret that you were hiring and its up to the people to step up and get involved. I want to say you all do a great job, you apply for every grant available and you keep garbage fees low and do every thing you can to keep fees down in the township, a number of roads have been paved and you support other institutions in getting grants.
