Chief Binker - suggested calling 911 when the trucks are idling so someone could respond and go and talk to the driver, being that they are on private property do we have the authority to tell them to stop idling. They also have to leave the truck run because of the fuel in the cold. Menn- I will talk with Karen about this and when we send the letter about the trees maybe we can include something about the idling. It may be a fuel issue it may not be, we have to look into it.

Karel Zubris – Hello Ladies and Gentlemen I here on behalf of some residents of Sandra Street in Plains and the Shimshock family behind me. We just want to know who what when and why is going on at the bottom of Hill Street. There were videos and graphics that were sent thru social media nothing was sent to the residents. Can someone send us what is being done their, who is doing it and why they are doing it to the Plains residents. Just so we have something to show. Everyone is concerned about the acid mine drainage that will be happening to our pools and our drinking water and we need some transparency to this issue. Maybe we missed something because we are all hard working people, tax payers and we all voted for you to be here, so come down and take a walk around and see what is going on, investigate it. I don't want to see something terrible happen here. With cancer in the area and that cell phone tower we have no idea what is going to happen. Come and meet with the neighborhood knock on their doors, tell them what is going to be happening. We have a ton of people who are just there to see what is going on – all hours of the night disrupting the wildlife and walking through the woods.

Commissioner Yozwiak – There was flooding in 2011 and the state addressed stormwater management. There was a lot of water from the Burgio property that we didn't own then and we purchased. I have a map of how the stormwater funnels into Bergh Street down at the bottom and then goes underground to a pipe that takes it through Hudson to the creek. We put in a Park plan to get grants WVSA asked us to put in a stormwater pond which will address the drainage issue of the stormwater. The engineers from A&E Group did a plan and we all signed off on it. This would be part of the park plan of trails and such so that we could get grant funding to make improvements. This is a wet pond not an AMD pond there is no acid mine drainage going into this pond other than stormwater. So I don't know where that came from. Lisa I did answer your email I don't know if you got it?

Lisa Shimshock - No I did not.

Commissioner Yozwiak – I did sent an email to you everyone on the board is copied on it. We have a copy of it here, to give you a copy tonight. So we had WVSA here with A&E group last month. Mr. Angeli was here and asked a ton of questions and he left here saying he was fine with the plan. Back in 1939 there was a pond there very close to where Sandra and Mill intersect. So we are putting this in. WVSA wanted to get a jump on the project because of the good weather. You are welcome to stop and see the drawings. It really is a good project for stormwater management.

Commissioner Cinti – I was up there and the opening is a bit large, but WVSA will be adding more trees and plants to the road opening, there are so many things that the park can have. Trails, pavilions. There won't be a parking lot here.

Commissioner Yozwiak – There is a gravel access road from Hill St. to the pond. This is specifically for the maintenance of the wet pond. WVSA is handling all maintenance and upkeep of the pond. The wet pond focuses on a natural process of slowing down the water allowing sediment to settle and then facilitating the drainage of the water. They will be adding additional trees and such to beautify the area.

Commissioner Cinti - There is a rain garden in the Municipal park that is along the same lines as this one will be.

Karel Zubris – Thank you for explaining. Bottom of Hill St. there is a drain and it gets very icy. I hope this will alleviate that. Right now there is an orange cone there. Because there is a large hole. Is there something that we can do about that.

Commissioners- Ok we will have them look at it. Commissioner Sax will take care of it.
