APPLICATIONS & QUALIFICATIONS

§ 3.1: Eligibility for Examination

Inorder to be eligible for participation in any examination for any position with the police department or fire department, every applicant must submit a completed application form to the commission before the deadline stated by the commission for that specific examination. The applicant must make an oath of affirmation that the application is completed truthfully and the applicant is subject to the penalties of 18 Pa. C.S 54904 relating to unsworn falsification to authorities.

§3.2: Discrimination

The Township of Plains is an equal opportunity employer. It is the Township of Plains' and the commission's policy to grant equal opportunities to qualified persons without regards to race, religion, color, national origin, gender, age, veteran's status, marital status or non-job related physical or mental handicap or disability. The Township of Plains will provide equal opportunities in employment and promotion.

§ 3.3: Availability

Application forms shall be available to all interested persons in the office of the secretary to the Board of Commissioners, and from such other offices and officers that the commission, from time to time, may choose to designate. Application forms may be mailed upon written or telephone request. However, the commission assumes no responsibility for missed filing deadlines due to a delay in the mail.

§ 3.4: Age and Residency Requirements (Revised 4/30/2024)

All applicants must have reached their eighteenth (18th) birthday before the deadline for submitting completed applications. Effective June 1, 2024, successful applicants for the Police Department who are hired by Plains Township must within six (6) months of completing their probationary period reside in Plains Township or within ten (10) nautical miles (11.5 statute miles) of the boundary of Plains Township. All successful applicants for the Fire Department hired by Plains Township must within six (6) months of completing their probationary period reside in Plains Township.

§ 3.5: General Qualifications

Every applicant for any position in the Police Department shall possess a minimum of an Associate's Degree or sixty (60) credits or three (3) years (minimum of 2080 hours) previous law enforcement experience. In addition, every applicant must be a United States citizen, be physically and mentally fit to perform the full duties of a police *officer*, and prior to appointment, possess a valid motor vehicle operator's license issued by the

Commonwealth of Pennsylvania, along with Act 120 certification. Also, every applicant must pass a physical agility test to be eligible to participate in the written examination. At the time of hiring from the Eligibility List, an applicant must pass a physical agility test and submit to testing for drugs

and alcohol.

Every applicant for any position in the fire department shall have a diploma from an accredited high school or equivalent, to be a United States citizen, be physically and mentally fit to perform the full duties of a fire fighter, and prior to appointment, possess a valid motor vehicle operator's license issued by the Commonwealth of Pennsylvania. In addition, every applicant must have completed an Essentials of Firefighting Course and possess. current certification from the Department of Health Emergency Medical Responder (EMR) certification. In addition, every applicant must successfully pass a physical agility test to be eligible to participate in the written examination.

3,7: Rejection of Applicant

The commission may refuse to examine, or, if examined, may refuse to certify as eligible after examination, any applicant who is found to lack any of the minimum qualifications for examination prescribed in the Rules and Regulations for the particular position for which the applicant has applied. In addition, the commission may refuse to examine, or if examined, refuse to certify any applicant who is physically or mentally unfit to perform the full duties of the position sought, or who is a habitual substance abuser, who is guilty of any crime involving moral turpitude, or of infamous of notoriously disgraceful conduct, or who has been dismissed from public service for delinquency or misconduct in office, or who is affiliated with any group whose policies or activities are subversive to the forms of government set forth in the Constitution and laws of the United States and the Commonwealth of Pennsylvania.

§3.8: Recording and Filing Applications

Applications for positions in the Police Department shall be received at the Plains Township Municipal Building only after an examination has been properly advertised and before the deadline for receiving applications which must be set forth in the public advertisement. Applications will be received by the municipal officer designated in the public advertisement or that officer's designee. That person shall record the receipt of all applications and provide each applicant with notice of the time and place for the first portion of the testing procedure, the written examination. Any application containing material errors or omissions may, at the discretion of the commission, be returned to the applicant for correction prior to the deadline for filling applications after which no new applications or amended applications will be accepted.

§3.9: Hearing for Disqualified Applicants

Any applicant or other persons who believed that they are aggrieved by the actions of the commission, in refusing to examine or to certify them as eligible after examination, may request a hearing before the commission. Within ten (10) days after such a request, the commission shall designate a time and place for the hearing which shall be conducted pursuant to the procedure set forth in the Local Agency Law, 2Pa.

C.S. @101 et seq. The applicant or aggrieved party must make their request for a hearing within ten (10) calendar days of the date when the party knew or should have known of the commission's action which is being challenged.

§3.10: Public Notice

The commission shall conspicuously post in the Plains Township Municipal Building an announcement of the hiring or promotional testing and set forth the time and place of *every* examination, together with the information as to the type of position to be filled, the requirements for that position, where applications may be obtained and the deadline for filing those applications. In addition, at least two (2) weeks prior to the close of the application period, publication of the notice shall occur in at least one (1) newspaper of general circulation or a newspaper circulating generally in the Township of Plains.
