Mr. Drozda – Karaoke, she goes out there with a microphone and sings karaoke, and not well Fran – They need to clean up the garbage too. Nothing has changed and the garbage is accumulating.

Menn- One of the motions we made tonight is to employee additional people to enforce those things.

Mr. Drozda - I have tried to help them a few times but they just don't want it

**Animal Control** 

I am here to talk about animal control issues – this started in 2024. There has been cat food placed behind the Sheehan's property, and I asked them to ask the people who were putting it there not to do it anymore. But they said they gave them permission and they were not going to take that back. The problem is these animals come into my yard and are destroying our property. I have had to repair my fence and shed, there are animal feces all over the yard. I went to the Twp. Zoning Officer, they told me to catch the cats. But there is an ordinance that says we cant catch the cats. But its not just cats.

Sax – what other animals?

Turner – I can show you – I have pictures, groundhogs, skunks, opossums, cats. Also pictures of the woman and the others feeding them. And now they also have food at the Dr.'s Office. Menn – In our ordinance they are allowed to trap neuter and release. Allowed to feed under the conditions in the ordinance.

Turner - They are not trapping them.

Menn – When they do trap them they return them to the place they got them.

Turner – it's a health hazard though.

Biscontini – Have Karen go and talk to them make sure they are following the ordinance.

Turner - They are not trapping them they are feeding them and bringing more.

Menn – The people who feed them are bringing more cats there?

Turner - Yes

Menn – you have seen them bring cats?

Turner – I can not verify that. But the food is drawing them there.

Menn – If they are not following the ordinance then we need to have a conversation with them.

Food and water must be removed at the end of each day.

Turner – They don't, they refill it at night.

Menn – well then we will have to have a conversation with them, because that is a violation. Not removing the food, will bring the other animals

Biscontini – We will have Karen go out and make them aware of the ordinance.

When my neighbors moved and left there three cats Whiskers World was given a donation to take these cats. They came the cats were gone and then after a few months they were back.

The skunks eat at 2:00am and wake us up. Chuck at Sheehan's says they did not give permission but they don't want to get involved. Because they don't want any kind of negative press.

Here are pictures of the food at the Dr.'s office. The other day someone dropped a whole bag of food in the middle of the road and just left it there.

Menn – It's their property they have a say

Allabaugh – But they don't want to say anything because of the controversy with the program Here are pictures of the food plates, cat houses the spilled food.

Turner – I would go and collect the food when they would put it out and in 24 hours I gathered a gallon jug of cat food so they started moving the plates further back.

Menn – this must be addressed with Brenda because they are violating the ordinance. We could also notify the property owners that they are in violation. I'm not telling you they can't put food out but there are conditions for doing it. It must be removed and spilling it on the street is defiantly a no no.

Allabaugh - I appreciate that. Thank you.

Ava Peterson -

Cemetery

I first became concerned with the conditions of Good Shephard Memorial Cemetary 5 years ago after hearing about its condition. After speaking with many family members and people in the community I decided I wanted to do something to help. A lot of my free weekends are spent at the cemetery replacing veterans' flags, cleaning up, cutting grass and weeds. Over the past few years the grass has been cut buy good Samaritans. However, the mausoleum has deteriorated significantly, the foundation is crumbling, plaques are falling off, there are holes in the walls. I know that no one has a good answer to this problem, so I don't expect a resolution tonight. I just wanted to bring this to your attention.

Sax – the one problem with this is there are no records on this cemetery.

Peterson – I know, I have been researching this for 5 years. On July 26<sup>th</sup> I found a casket on the outside exposed. I think this is very concerning. I know it's a privately-owned building but this should be rebrick or covered somehow.

I don't want to come to you with just problems but I can't find a solution. I understand the owners refuse to take responsibility. Lee is going to be 90 years old you can't exactly put him in jail. I don't know if maybe there are some kind of grants that can be gotten.

Menn – Yes but its private property, we can't exactly go in there and do anything.

Sluhocki - what if we had their permission?

Menn – and spend Twp. funds then?

Sluhocki - No but maybe board it up?

Menn – maybe do a fundraiser and get the owners permission to go in there and fix it.

Peterson - The owners won't acknowledge it.

Menn – its kind of late for that, the court has deemed them responsible.

Sax – We know there is a serious problem there and we have been dealing with it for years but we have no good answers.

Menn – Funeral directors need to get a court order to remove the bodies for reinternment Peterson – As far as I can tell there are about 25 bodies left in the mausoleum.

Biscontini - So are the taxes paid or is it in repository?

Menn - its in repository, but no one is going to buy it

Peterson – The amount of money it would take someone to just tear the mausoleum down is great.

Menn – The problem is its not an everyday structure that we can just take over and knock down because there are people left in there. And most of them don't have family around anymore or they would have removed them already.

Peterson – I spoke with one woman who has family there but she can't afford to have them removed. I just want to thank you for your attention and for listening. Cinti – Thank you.
