Bernard Prev - Cemetery Road and ATV's

First, I would like to bring to your attention Cemetery Road from the top of Heavenly Acres to Michelle Street. It may not be the Townships road but it is used by the Township and residents and it needs to be filled. Its washed out pretty good. I have called about this several times, and was told it was given to you folks.

Attorney Menn - It is private property so we can't just go and do maintenance.

Prev – It is being utilized. What if we get permission from the owner or the diocese, then the township could dump stone and get the Holy Redeemer kids that need hours to spread it and fill the holes Does that sound like a possibility?.

Sax – maybe we can get millings from the Hudson Rd. project to fill it if we have permission. Cinti – maybe we can take the millings up there that is a good idea.

Prev – my concern is the school buses and delivery trucks – its just in bad shape. The water company had a break there a few months ago. They added some rock to fill it in. If it isn't utilized then it should be closed.

Cinti – we do have some ideas now, but we would need permission from the diocese.

Menn – My suggestions is looking at it as a lawyer the board will look at options and discuss it, as I have some concerns with it.

Prev – one other item, we talked about this about a year ago, It is a state law not to be driving atv's and dirt bikes on the road. I have to credit the police they are trying to stop it. These guys are on your property and are not staying off, they have no consideration. The policing of trying to keep them out of there. I am asking for consideration, Friday nights there are 6 to 7 atv's going up and down the road. Maybe a curfew of 9 or 10 pm to

Biscontini – our police are trying, but by the time they get there they are gone.

Prev – state law says the vehicle can be confiscated they can be sited. If you could think about a curfew.

Maybe if the police officers can sit there at 10:30 to 1:30 at night. We can't leave our windows open. So just consider it.
