And they have still not been cited.

I made one more attempt to speak with my neighbor and quite frankly it was appalling. He told me that they do not like to be controlled. When I asked him about why the music has to be so loud he responded, it's not that loud and I can make it louder. When I asked if he was tired of the cops showing up he replied that they can't do anything. I made 4 calls to 911 on Saturday regarding the music and loud singing and nothing was done. And again, why did they not have to get any permits for their projects. They only one they recently got was for the shed they put up. We had Ismael himself tell us that there was an electrician there. We want to know what is going to be done about it.

Sax – BHW was there to get them to clean up the property. We have been by and it is cleaned up in the front. I know there is still some things in the back.

Karen – When I asked Ismael if there was work done in the house he said no. How can I prove that there was work done?

Mr. Drozda – they did work, there was 30 to 40 sheets of drywall delivered there. Do we have a noise ordinance yet?

Attorney Menn – yes we have an ordinance, but here is the thing what is a nuisance to one is not always a nuisance to someone else. And what is loud for one is not for another. The police have to enforce it.

Mrs. Drozda – They come and they talk and the police leave and she comes out and tortures us for hours. But the big thing is the permits – how come they haven't been fined for the work.

Mr. Drozda – shouldn't the house be inspected.

Menn – I'm not sure what you mean. When you buy a house there is an inspection done. They got that. After that unfortunately the system is set up that after that we trust everyone to go to the township and tell us when they are doing work and get a permit. If they don't do that we have no way of knowing or proving they did work.

Mr. Drozda – what if someone told you they were doing it.

Menn – again if we go there and knock on the door and they say no, no work was done, what are we supposed to do?

Mr. Drozda – so then none of us should ever take out a permit

Menn – If that is what you want to do and that is the neighborhood you want to have then yes. But that is not the way it is supposed to work. All we can do is go to them and ask if they are doing work.

Mr. Drozda – another thing they had a nice lawn at one point and they tore it up and now they have no grass. Don't they have to have grass? It looks like hell.

Mrs. Drozda – We are trying to help you, this is one family right now but they are looking to buy more property. They will ruin the neighborhood and the township.

Sax – well I will ask code enforcement to knock on the door and ask again if any work was done, however if they say no and won't let them in there is nothing we can do.

Biscontini – we can not make the officers cite them, BHW is aware of the issue we will ask them to keep an eye on the situation.

Crescent drive resident - Are they legal residents? Are they legally in the united states?

Menn – How would we know that?

Resident – why wouldn't you know, are you telling me that anyone can come here and buy a house and do what they want?

Menn – No I'm not telling you that but how could we know if they are a legal resident

Sax – we will call code enforcement again tomorrow morning.

This will tie into what they are saying about people moving in and doing what they want. We live in Heavenly Acres and the roads are small. We have people that have moved in from out of state and they have decided to bring commercial trucks in and leave them there and idle them at 4 am. The act 124 gives the police department to go there for the idling. They have employees also. So, they are running a business out of this house. They bring in appliances from some where and drop them in their driveway and then all day long other trucks come and pay him for the appliances and pick them up and leave with them. These trucks block our driveways and pay cash for the appliances. What is to stop them coming from other states and doing this in every developments.

Sabach – I am also requesting a sign not to block the driveway.


Sax – the first thing we need to do is stop him from running the business.

Sax – we will start with the home business issues.


